

2006 PRIORITIES



1. The Right Infrastructure

Getting the right investment from both private and public sector, in the right place and in time to support, the peak performance and optimum efficiency of Australia's logistics system is absolutely essential.

2. Capable People

ALC recognises that the logistics system must have the right people, well led, with the right skills in the right numbers and in the right place at the right time. Indeed investment in Infrastructure must be matched by investment in people.

3. Streamlining Rules and Regulation

ALC will work closely with the Australian Transport Council (ATC), the Standing Committee on Transport (SCOT) and all Australian Government as well as the National Transport Commission (NTC) in 2006 to continue efforts to reduce red tape, achieve national consistency of regulation and argue the case for appropriate priority for transport and logistics in decision-making.

4. Understanding the Future of T&L

ALC is well positioned to lead a future visioning process for the industry in 2006. While overseas experience provides some examples Australia's situation as a remote, sparsely populated island continent, heavily dependant on the export of raw material poses unique challenges for transport and logistics. It certainly means that T&L costs are a large proportion of the costs of both domestic and international trade.

The Australian Logistics Council (ALC) is a partnership between Australian Governments and senior leaders of the logistics industry, including providers, users, peak bodies, regulators, and other industry specialists.

The ALC Annual Forum 2006 is a unique opportunity to hear from the Minister for Transport and other senior industry figures on the role of transport and freight logistics in the Australian economy and to set the National agenda for 2006-07.

A major task for the Australian Logistics Council is to tackle the barriers currently imposed on freight-related infrastructure. To ensure industry priorities are addressed, a section of the Forum has been dedicated to facilitate an open discussion on the topic.
