### **FIATA Invitation for Validation**

- FIATA extends invitation to NFFAs at least 4 months before HQ Sessions or FWC to all NFFA
- All Validation Applications to send to FIATA not later than 60 days prior to HQ Sessions or FWC event
- Applications received after the 60 days period will be taken into account for the following event







#### **Validation Procedure**

- Main Objective of Validation Procedure to obtain a comprehensive view on training materials which will be used for delivery of Vocational Education (manuals, syllabus, tutorials, assessment criteria)
- Questionnaire one of the key element for successful validation. It should be carefully completed, providing max details and relevant information
- NFFAs should have already completed at least 2 successful runs of their training programmes





#### **Validation Procedures**

 Documentary Records on the 2 successful runs should be submitted to FIATA (Trainees Profiles, Course Evaluation, Trainees Attendance Records, Course Summary Reports, Specimen of Exam Questions & Answers and the Summary Results)



 Mandatory that NFFAs should conduct at least 1 successful run per year after FIATA Validation of their training materials





### **Validation Session**

 For new Validation Application, a representative familiar with the NFFAs' training structure and the course content to be delivered *must attend*

the scheduled Validation Session during HQ Session or FWC







#### **Revalidation**

All validated Training Programmes
*must be re-validated* by FIATA at
max. intervals of 4 years



- Re-validation is also necessary if there are major changes/updates to the course content, structure or delivery, etc.
- for re-validation, physical presence is not mandatory, but highly recommended







# **Re-validation**

- Total Validated National Training Programme = 40 from 38 countries
- however, more than 50% of validated training programmes were validated since 1996 !



- FIATA seeks to review their training programmes to ensure its relevancy to current developments and changes to the international industry practices
- FIATA will seek the NFFAs to apply for *re-validation*





# **Guidelines on Minimum Training Hours**

 must be at least a total of 200 contact-hours, preferably more, in order to have the sufficient depth on all the subjects mentioned in the "FIATA Minimum Standards (FMST) to obtain the FIATA Diploma in Freight Forwarding by Vocational Training & Examination"







#### **Language Medium**

 Synopsis of the Course Materials, Curriculums and all necessary write-ups for Validation must be submitted in *English*, if the course materials and delivery is not conducted in English...
